

Participatory Arts Activity with Children and Young People

The questions included in this section on children and young people are split across four pages as follows:

- 1) Projects specifically targeted at children and young people in schools/education (Q1-Q15)
- 2) Projects run specifically for children and young people in general i.e. outside the education/school setting. For example in a youth club (Q16-Q28)
- 3) Regularly scheduled Youth Theatre, Youth Music, Youth Dance, Youth Performance Arts. These groups differ from the other participatory work in that they meet regularly and often lead to public performance (Q30-Q35)
- 4) Children and young people's participatory activity targeted at specific protected characteristic groups (Q36)

Please only include participatory sessions which your organisation has run as part of your programme. If you have hired out space at your venue for workshops and this is the only input your organisation has had in the process, these should not be included.
